## Rheolau • Rules & Regulations

1. The Society reserves the right to limit entries to 110 (55 per day). The Society reserves the right to refuse an entry.
2. A competitor may enter only once with one dog (the registration number must be supplied). No competitor will be allowed to enter twice.
3. A draw will be held to determine the running order for each day. The competitions will be run strictly to programme. Entrants may be drawn to compete on either the Tuesday or the Wednesday. All entrants who are not drawn will be notified immediately following the draw.
4. Competitors failing to report at the times specified in the running order and not present when called will forfeit their runs, unless they have previously notified the Stewards of their inability to attend. Competitors may appeal to the Chief Sectional Steward.
5. No dogs, except those competing, will be allowed on the course.
6. All dogs, except when competing must be held by a cord or chain, offenders will be under a penalty of disqualification.
7. Any dog that grips a sheep will be disqualified immediately and the owner held responsible for any damage caused. Any competitor who acts in an improper way is immediately disqualified and reported to the Society.
8. The Society is responsible for setting the course and the time allowed for each dog will be announced on the field.
9. The Judge or Judges shall have power to call the handler at any time to retire from the competition and to clear his or her sheep off the course.
10. Every competitor to re-pen the sheep after completing his or her run.
11. The Judges are not to be interfered with, or spoken to, except through Field Stewards. Any competitor who interferes or speaks to a Judge directly makes himself or herself liable to an immediate disqualification.
12. Any bitch in season, if her owner reports her condition to the Chief Sectional Steward before the trials commence and is confined to the vehicle before and after the run will be allowed to compete.
13. It is the responsibility of the Judge to grant a re-run. The re-run will count from where the original was stopped and the points scored or lost before the stoppage took place stands.
14. In the event of a tie for any of the Trophies, it will be decided on best out-run, lift and fetch.
15. Judges are expected, whenever possible, to give out marks gained or lost as soon as possible after the completion of each run.
16. No protests will be entertained unless given in writing and lodged with the Chief Sectional Steward or one of the Stewards within 30 minutes of the final judging. The protest must be accompanied by a £50.00 deposit which shall be forfeited if the objection be deemed frivolous. The decision of the Society will be final.
17. The decision of the Society will be final on all matters.
18. The Society accepts no liability whatsoever for any loss or damage that may be caused during the Trials and that the public are on the ground at their own risk.
19. The Society will not be responsible for any error that may occur in this Schedule.
20. The Competitions will be held in accordance with the guidelines issued by Welsh Government.
21. The Society advises competitors not to leave dogs in cars.
22. **No dogs will be allowed within the showground perimeter fence unless competing in the Main Ring Competitions.**
